Call to Order

The JCC Board of Directors meeting was called to order by Patrick Hocking at 3:00pm. A quorum was present. Jennifer submitted election proxies for Eric Hunter, William North, Brenda Johnson, and Matthew Sinnott.

<u>Declaration of Conflicts of Interest</u> – Patrick presented an opportunity for Board members to declare any conflicts of interests in the discussions on the agenda.

<u>Consent Agenda</u>: Board members reviewed the consent agenda for today's meeting. The meeting agenda and minutes from the November 14, 2019 study session were reviewed. It was noted the Finance Committee will not convene in December, therefore the September 2019 financials will be reviewed and approved at the January 9, 2020 board meeting.

Governance Update – Mark Orndoff

Mark noted with Michelle Homer-Anderson's resignation from the board and the election of two new members, the board member total will be 14; leaving one open seat on the board for future consideration.
