### **Summary of Minutes**

# Call to Order:

Co-Chair called the meeting of the Jackson Care Connect (JCC) Community Advisory Council (CAC) at 12:13pm. December minutes were approved.

## Coordinated Care Organization (CCO) Request for Proposal (RFP) Update: Jennifer & Belle

- CCO 2.0 Request for Applications (RFA) was released a week ago. RFA is out in preparation for the new CCO 2.0 policies. OHA is looking to increase the engagement of social service partners and meeting the needs of our members. CCOs are being asked to integrate behavioral health in a variety of services and access and reduce costs. Jennifer is comfortable on the direction of our organization. It is very validating that a lot of our work already aligns with CCO 2.0 requirements.
- Jennifer wants the CAC to be very aware of what we (JCC) are committing to and she will be back to bring draft RFA for review and input by the CAC. Questions and discussion held.

## CCO 2.0 Policy Review: Belle

Belle went over her written report Policies 1-9 and provided the link shows entire policies. Jennifer stated we are already preforming most of these policies, if anything it will be a slight shift for JCC.
