CHIP/SHARE Grant update

- Request for Proposals (RFP) went live on 2/27/26
 - RFP closes on 3/31/26
- Total of \$200,000 to be awarded
 - \$50k is CHIP funding
 - \$150k is SHARE funding
- CAC will be responsible for awarding \$50k
 - Will make recommendations for remaining funds
- Some applications will be eligible for only SHARE, only CHIP, or both
- Watson and Hansen will do initial screening of all applications received
 - Will give CAC 10 eligible applications for review

- There will be multiple opportunities for CAC to review applications with JCC staff
 - Available dates and times will be sent to the CAC once finalized
- Rosenthal will send out guidance document to CAC once finalized
