Call to Order:

Approval of Minutes:

Word on the Street – All

Hearing Loss Association had a support group meeting last week with folks from Southern Oregon OLELO is an app that was shared that is free for folks who experience deafness and hearing loss. It is available on Android and Apple platforms. It captions real time conversations and is available in English. Not certain if it is available in Spanish

There is an online forum discussion taking place tomorrow from 6-8 pm for people who might be interested discussing aging and setting what would be an agenda for the future of supports to aging community members and folks that would be caregiving for elders in the state of Oregon.

Health Assessment Review – Melissa Gharst

- Melissa is looking for input on the Health Assessment that is given to CareOregon Advantage and Jackson Care Connect members. They are currently two separate assessments but are wanting to streamline and make them into one.
- Began doing this question by question. There was not enough time. Melissa will send the most recent version of the HRA to Michael, and he will send it out to the CAC.
- Feedback was given that there was nothing in the assessment regarding fall risk and adjusting the options available for gender identity and pronouns. Melissa made note of the feedback.
- Hoping for feedback on all of it, but especially around transportation and food insecurity.

During the last statewide Tribal Advisory Council meeting, OHA and the state tribal representatives recommended that each CCO adapt a formal consultation policy on how they (the CCOs) should consult and work with tribes and tribal stakeholders in their areas and to develop those consultation policies. For example, deciding what would be what they call a critical incident or critical question that we (CCOs) would want to elevate to the tribes, knowing who the CCO contacts would be and/or how they would prefer we (CCOs) engage them.

Troy can give examples of what the state’s Consultation policy looks like if anyone requests it.

CHIP Grant First Review Continuation – Michael and Nancy

- An additional \$10, 000 was secured to add to the CHIP grant funds. There is now \$145,000 available for the CHIP grants this round.
- Conversation was had regarding which grant proposals could possibly be funded out of COVID funding versus the CHIP grant funding. Two applications were identified with the possibility of more being identified through the discussion had today
- Conversation had regarding what grant requests will move on by way of what score would be the cutoff to continue to the second round which includes a second review and site visits.
- It was asked if each grant was reviewed by more than one person, that that could very much affect where they might land in the order of what grants proposals move on to the second round. NO, Each grant proposal was only reviews by one CAC member, though some CAC members reviewed more than one grant proposal. Recommendation for a second review for ALL proposals was given.
- Training for how the site visits would be conducted will likely be scheduled so that folks feel ready to ask questions of the organizations and get the info needed.
- More conversation surrounding a second review of each grant proposal, Michael checked with CAC members and confirmed that second reviews and site visits would only be done on those already identified, no second reviews done on the others. CAC members expressed that they were comfortable, and this is what would move forward.
- An additional meeting WILL BE had this week to plan for site visits
- Request was made of the CAC to respond to email by end of day the following day (11/9) for possible meeting times
